WHILE CHILDREN ENHANCE CREATIVITY, BUILD CRITICAL-THINKING SKILLS AND HONE PHYSICAL DEVELOPMENT, PARENTS LEARN MORE ABOUT THE CHILDREN THEY CARE FOR AND HOW TO HELP THEM LEARN THROUGH PLAY, PREPARING ADULTS TO FOSTER CONTINUED GROWTH AND DEVELOPMENT.
